**President's Report:**

**Treasurer's Report:**

**Business Arising:**

**General Business:**

Centenary Lakes athletics track is undergoing an upgrade and is unable to be used for approximately 6 months. The cost is more expensive than Centenary Lakes so thanks to everyone for paying \$2 per family each Thursday.

Glasshouse Trail Runs are now being organised and managed by the Run Inn. It has been indicated by Bruce Cook that CRR will still be able to assist with Flinders Tour in July as our main fund raising venture. He also indicated that for added income CRR would be able to help at Glasshouse 100 in September as shorter races are planned to be incorporated.

CRR will continue to reimburse members the cost of one race entry up to value of \$95.00 if they help out at the Glasshouse runs with checkpoint duties etc.
